

The closure has a special tear-off membrane, which effectively seals the product prior to being opened. However, apart from serving as a tamper-evident seal, it also saves the additional cost of hot-foil sealing and tamper-evident shrink sleeving.

The primary and secondary sealing ensures effective leak-proofing. While the mating of the closure with the mouth of the bottle serves as primary seal, the mating of the screw over-cap with the internal diameter of the pouring surface of the base cap ensures secondary sealing. Both guarantee double leak-proofing.



REGULATED FLOW



The closure has a designed-in 'marguerite' type flow regulator for more precise and smooth dispensing of edible oil. The elasticity of the flow regulators dampens the flow of the viscous edible oil, which allows air to enter the bottle at the same time while the oil is being poured; thus preventing sudden spikes in oil pouring.

Normal bottles have a flat face at the mouth. Due to this, drops of oil tend to flow down the bottle and stick to the outer portion of body. However in this case, the specially curled (radiused) non-drip lip on the base-cap prevents the last drop of oil from remaining or pouring down the rim, thus preventing oil spillage after pouring.




